1. The BUYER agrees to pay the BREEDER a non-refundable **Reservation/Service Fee of \$500 (Five Hundred Dollars)** by PayPal invoice OR Zelle bank transfer.
2. This is a reservation/service fee for the BREEDER's service of holding and reserving the PUPPY for the BUYER until the PUPPY is ready for pickup at 8 weeks of age.
3. The BUYER agrees to pickup the PUPPY from the BREEDER's address between the following dates: ____/____/____ and ____/____/____ - at a time that is agreeable to both parties.
4. The Reservation Fee of \$500 will be applied to the purchase price of the PUPPY and the BUYER will pay the BREEDER the remaining balance in CASH at pickup. The PUPPY may not leave the BREEDER's premises until the balance is paid in full.
5. The BUYER understands that the BREEDER does not offer shipping or transportation for Puppies. The BUYER agrees to pick up their PUPPY in person (only the BUYER(s) on this contract can pick up the PUPPY, no representatives) at the BREEDER's address (on this contract).
6. If the BUYER changes their mind or decides not to purchase the PUPPY for any reason OR the BUYER does not pickup the PUPPY from the BREEDER's address between the dates of ____/____/____ and ____/____/____, the BUYER understands that the BUYER will forfeit their \$500 reservation fee and the \$500 reservation fee will be kept by the BREEDER with no further obligation to the BUYER.
7. The PUPPY will be sold only for the purpose of a **Pet (Companion Animal)**. While the PUPPY may be capable of performing other functions, no warranty will be given as to its fitness for any other purpose than as a Pet. The PUPPY will be sold as a **PET with NO BREEDING RIGHTS** and **non-breeding registration papers**. The BREEDER will provide the BUYER with **either AKC Limited or UKC Registration (non-breeding papers), of the BREEDER's choosing after receiving proof from the BUYER that the PUPPY has been spayed/neutered by a licensed Veterinarian**.
8. The BUYER has read the BREEDER's "Terms" and "Puppy Sales Contract". The BUYER agrees to the BREEDER's terms, conditions, and policies.

9. All parties, without any emotional or mental reservations whatsoever, are freely entering into this contract.
10. Contract and guarantees are only implied between the BREEDER, and the original BUYER, NOT to a third party. This contract and guarantees are not transferable.
11. The BREEDER reserves the right to cancel the sale, issue a refund, and not sell the PUPPY to the BUYER for any reason and at any time prior to the PUPPY leaving the BREEDER's possession.
12. This is a legally binding contract, controlled by the laws of South Carolina. It is agreed that if there are any disagreements between the BREEDER and the BUYER, that they will be settled in Berkeley County, South Carolina.
13. Any costs of litigation will be paid for by the BUYER.

The written terms of this contract contains the entire agreement between the BREEDER and the BUYER. No other written, verbal, or implied statements, promises, documents, or writings shall have any effect on this contract unless these terms are reduced to writing, signed by both parties, and attached.
