Only CASH is accepted at pickup for the remaining balance still owed on your PUPPY.

The Terms:

1. The Reservation Fee of \$500 will be applied to the purchase price of a PUPPY of the BUYER's preferred gender and choosing within the next 12 months (365 days). The BUYER will pay the BREEDER the remaining balance in **CASH at pickup**. The PUPPY may not leave the BREEDER's premises until the balance is paid in full.
2. The BUYER agrees to pay the BREEDER a non-refundable **Reservation/Service Fee of \$500 (Five Hundred Dollars)**. The Reservation Fee may be used towards the purchase of a Beagle PUPPY from the BREEDER within the next 12 months (365 days).
3. This is a reservation/service fee for the BREEDER's service of holding and reserving a Beagle PUPPY of the BUYER's preferences above, for the BUYER to purchase.
4. For Next Available/Future Litters - The BREEDER will offer every PUPPY that they do not keep for themselves to the families on the BREEDER's Waiting List, in the order that they joined the Waiting List (based on their gender preferences).
5. The BUYER will choose their PUPPY from pictures sent from the BREEDER by email.

6. When it is the BUYER's turn to choose a PUPPY, the BREEDER will attempt to contact the BUYER by email and text (phone) based on the contact information on this contract. If the BREEDER does not receive a response within 24 hours, the BREEDER will skip over the BUYER until another PUPPY becomes available to offer the BUYER (The BUYER will have 24 hours to choose/skip/respond when offered a PUPPY).
7. The BUYER understands that the BREEDER can only guarantee to offer the BUYER a Black Tricolor (Black Tan & White) PUPPY of the BUYER's preferred gender preferences. Any "other colors" are very rarely born in the BREEDER's litters, are individually priced at the BREEDER's discretion, and cannot be guaranteed available; however, the BUYER may choose to apply their reservation fee to a PUPPY of "other colors" should one become available.
8. If the BUYER changes their mind or decides not to purchase a PUPPY within 12 months (365 days) for any reason, the BUYER understands that the BUYER will forfeit their \$500 reservation fee and the \$500 reservation fee will be kept by the BREEDER with no further obligation to the BUYER.
9. After the BUYER chooses a PUPPY, the Reservation Fee is non-transferable to another PUPPY; except in the event of the PUPPY's death prior to pickup OR if the PUPPY fails a Veterinary Inspection/Exam prior to pickup.
10. The PUPPY will be sold only for the purpose of a **Pet (Companion Animal)**. While the PUPPY may be capable of performing other functions, no warranty will be given as to its fitness for any other purpose than as a Pet. The PUPPY will be sold as a **PET with NO BREEDING RIGHTS** and **non-breeding registration papers**. The BREEDER will provide the BUYER with **either AKC Limited or UKC Registration (non-breeding papers), of the BREEDER's choosing after receiving proof from the BUYER that the PUPPY has been spayed/neutered by a licensed Veterinarian.**
11. The BUYER understands that the BREEDER does not offer shipping or transportation for Puppies. The BUYER agrees to pick up their PUPPY in person (only the BUYER(s) on this contract can pick up the PUPPY, no representatives) at the BREEDER's address (on this contract) on the date or within the following 7 days of the date that the PUPPY turns 8 weeks old. For puppies reserved after 8 weeks old, the BUYER must pick up the PUPPY within 7 days of the reservation.
12. The BUYER has read the BREEDER's Terms and Beagle Puppy Sales Contract. The BUYER agrees to the BREEDER's terms, conditions, and policies.
13. All parties, without any emotional or mental reservations whatsoever, are freely entering into this contract.
14. Contract and guarantees are only implied between the BREEDER, and the original BUYER, NOT to a third party. This contract and guarantees are not transferable.
15. The BREEDER reserves the right to cancel the sale, issue a refund, and not sell the PUPPY to the BUYER for any reason and at any time prior to the PUPPY leaving the BREEDER's possession.
16. This is a legally binding contract, controlled by the laws of South Carolina. It is agreed that if there are any disagreements between the BREEDER and the BUYER, that they will be settled in Berkeley County, South Carolina.
17. Any costs of litigation will be paid for by the BUYER.

The written terms of this contract contains the entire agreement between the BREEDER and the BUYER. No other written, verbal, or implied statements, promises, documents, or writings shall have any effect on this contract unless these terms are reduced to writing, signed by both parties, and attached.
